Licensing Updates

LBEDN's renewal period opened on April 15th. Please be sure to renew your Louisiana licensure prior to the June 30th deadline.

2020 Licensure Renewal fees are as follows:

Renewals submitted from April 15th - June 30th

Active Renewal \$80 Inactive Renewal \$45

Renewals submitted from July 1 - August 31

Delinquent Active Renewal \$160
Delinquent Inactive Renewal \$90

If you fail to renew, and reinstate your licensure within the first fiscal year of lapse, you will incur the reinstatement fee plus the Delinquent Active Renewal fee.

Before you begin your renewal:

- Please review all information in your Licensee Dashboard and update as needed.
- Please add/edit your current Employment Information.

Please Be Prepared While Completing Your Online Renewal:

- LDNs must upload a copy of <u>current CDR card</u> (LDN ID card, CDR letter or receipt, or expired CDR card will not be accepted). When entering your CDR information, please be sure to enter your CDR number as it appears on your card, without any letters or symbols. Your CDR number should be between 5 and 8 digits. THIS IS NOT YOUR LOUISIANA LDN LICENSE NUMBER.
- Provisional LDNs must attest to completion of 15 continuing education hours and upload supporting documentation to renewal application. A Supervision Form must also be uploaded into the application if employed in dietetics/nutrition.

COVID-19 Updates

The LBEDN has had no interruption of services during the COVID-19 crisis. Board staff has been working remotely since March 17, and remains available to assist with applications, licensure questions, license verifications, etc. LBEDN staff and Board members continue to be efficient, with applications being processed and approved in as little as 24 hours.

Telenutrition in Louisiana

The provision of telenutrition in Louisiana is covered under the Louisiana Dietetic/Nutrition license. When telenutrition is used and the Dietetic/Nutrition practitioner and the patient or client are located in different states, the Dietetic/Nutrition practitioner providing the patient care services must be licensed in the state where the patient is located.

Board Member Vacancies

The Board currently has two board member positions that will become vacant on October 27, 2020 and December 15, 2020. These positions are for Licensed Dietitians/Nutritionists who are selected by the Governor from a list submitted by the Louisiana Academy of Nutrition and Dietetics. Nominees who are Licensed Dietitians/Nutritionists shall be residents of the state who have an unrestricted license to practice in the field of dietetics or nutrition or a related field for not less than five years. The positions are for three year terms. The Board meets four times a year at the Board office in Prairieville.
