

**Consent Agreement and Order

This matter came before the Louisiana Board of Examiners in Dietetics and Nutrition (hereinafter referred to as "Board") pursuant to an application for a license to practice as a Licensed Dietitian/Nutritionist filed by Julie Lyles Clement, hereinafter referred to as "Applicant").

The application was received by the Board on October 27, 2014.

Information received in the application process reflects that Applicant practiced as a Registered Dietitian from June 1, 2014 through the present time in violation of Louisiana Revised Statute 37:3085 and 3090 and LA R.S. 49:955(D). The Board has submitted this Consent Agreement and Order to Applicant and Applicant has signed the Agreement duly acknowledging the following:

1. By submitting the application, Applicant accepts the Board's jurisdiction;
2. Applicant has by his/her subscription hereto acknowledged the substantial accuracy of the foregoing information and that such information could provide the Board with probable cause to deny a license to Applicant because a violation of La. R.S. 37:3090 (A), La. R.S. 37:3091 and the *Rules and Regulations* of this Board;
3. Applicant has been provided an opportunity for a compliance hearing before the Board pursuant to Rule 501 of the Board's *Rules and Regulations*, which right as well as any legal or administrative rights Applicant formally waives by the execution of this agreement.
4. Applicant has executed this agreement as a free and voluntary act and with full knowledge and with the terms and conditions of the Order set out herein.

Considering the foregoing information and acknowledgments and waivers by the Applicant, the Board is persuaded that it is in the best interest of the public to enter into this Consent Agreement and Order and therefore, pursuant to the authority vested in the Board.

Julie Lyles Clement was granted a **Provisional Licensed Dietitian/Nutritionist** through August 1, 2015, and it is HEREBY ORDERED that Julie Lyles Clement is granted a **Licensed Dietitian/Nutritionist** license, subject to the following terms and conditions:

1. Applicant successfully completed the Board's Open Book Examination on July 10, 2015, which covered the Louisiana

Dietetic/Nutrition Practice Act and the Board's *Rules and Regulations* to include Rule No. 113 *Ethical Standards*.

2. Ms. Clement shall pay a fine in the amount of \$1,000.00 within one (1) year from the date all parties sign this Consent Agreement and Order. Such fine is authorized by La. R.S. 37:3092(B). Quarterly payments shall be remitted by either certified check, money order or credit card. The first payment is due within 90 days from the date all parties sign this Consent Agreement and Order.
3. Publication of the Consent Order in the LBEDN newsletter, as well as notification to the Data Bank, the Academy of Nutrition and Dietetics (AND)/Commission on Dietetic Registration Ethics Committee (CDR), and employer on record.
4. If Applicant fails to successfully and timely complete all requirements set forth in paragraphs one and two above within 90 days of all parties signing this Consent Agreement and Order, the Applicant's license shall be **SUSPENDED** without further notice until such time as the Board received and accepts documentation of applicant's completion of the requirements set forth above.
