CONSENT AGREEMENT AND ORDER

This matter came before the Louisiana Board of Examiners in Dietetics and Nutrition (hereinafter referred to as "Board") pursuant to an Application for License to practice as a Licensed Dietitian/Nutritionist filed by Sarah Tamplin, hereinafter referred to as "Ms. Tamplin".

The application for licensure was received by the Board on June 10, 2024. Information obtained through the application process indicates that Ms. Tamplin has been employed since June 14, 2024, as a "Assistant Director of Sports Nutrition", wherein she does "clinical, administration, and food service". This conduct is considered "dietetics/nutrition practice" as defined in La. R.S. 37:3091(1) for which a license is required.

The Board has denied your application for licensure for practice without the benefit of a valid license in Louisiana from June 14, 2024 to the present (September 5, 2024), in violation of Louisiana Revised Statute 37:3090 and 37:3091.

The Board has submitted this Consent Agreement and Order to Ms. Tamplin and Ms. Tamplin has signed the Agreement as provided for in Rule 503 of the Board's *Rules and Regulations* and LA R.S. 49:955(D) of the Louisiana Administrative Procedure Act, duly acknowledging the following:

By submitting the application, Ms. Tamplin accepts the Board's jurisdiction.

1. Ms. Tamplin has by her subscription hereto acknowledged the substantial accuracy of the foregoing information and that such information provides the Board with probable cause to deny a license to Applicant because of a violation of LA R.S. 37:3091 and the *Rules and Regulations* of this Board;

2. Ms. Tamplin has been provided an opportunity for a compliance hearing before the Board pursuant to Rule 501 of the Board's *Rules and Regulations*, which right as well as any legal or administrative rights Ms. Tamplin formally waives by the execution of this agreement.

3. Ms. Tamplin has executed this agreement as a free and voluntary act and with full knowledge and with the terms and conditions of the Order set out herein.

By practicing as a Dietitian/Nutrition without a valid license, Ms. Tamplin has violated LA R.S. 37:3091 which is cause for disciplinary action pursuant to LA R.S. 37:3090(A)(4) and (5).

Considering the foregoing information and acknowledgments and waivers by Ms. Tamplin, the Board is persuaded that it is in the best interest of the public to enter into this Consent Agreement and Order and therefore, pursuant to the authority vested in the Board by LA R.S. 49:955(D).

IT IS HEREBY ORDERED that Ms. Sarah Tamplin is granted the Licensed Dietitian/Nutritionist license, subject to the following terms and conditions:

1. Within ninety (90) days, Ms. Tamplin shall take and pass the Board's Open Book Examination covering the Louisiana Dietetic/Nutrition Practice Act and the Board's *Rules and Regulations* to include Rule No. 113 *Ethical Standards*. The minimum passing score of 80% must be obtained. A total of three (3) hours are given to complete the entire examination online. Applicant must pay all related testing fees.
2. Ms. Tamplin shall pay a fine in the amount of \$250.00 within ninety (90) days from the date all parties sign this Consent Agreement and Order. Such fine is authorized by La. R.S. 37:3092(B). Payment shall be remitted by debit/credit card.
3. Publication of the Consent Agreement and Order by LBEDN, as well as notification to the Academy of Nutrition and Dietetics (AND)/Commission on Dietetic Registration Ethics Committee (CDR), as well as reporting to the National Practitioner DataBank (NPDB).

4. If Applicant fails to successfully and timely complete all requirements in the time frames set forth above, the Applicant's license shall be **SUSPENDED** without further notice until such time as the Board receives and accepts documentation of Applicant's completion of the requirements set forth above.

Waiver of Rights. Ms. Tamplin is aware that she has the right to consult with an attorney of her choice and understands that she has the right to an administrative hearing on the facts in this case. She understands and agrees that by signing this Consent Agreement and Order, she is waiving her rights to a hearing. Further, she understands and agrees that she is relieving the prosecutor of any burden it has of proving the facts admitted above. Ms. Tamplin further understands and agrees that by signing this Agreement she is voluntarily and knowingly giving up her right to present oral and documentary evidence, to present rebuttal evidence, to cross-examine witnesses against her, and to appeal the Board's decision.

Effect of Non Acceptance of Agreement. Ms. Tamplin agrees that this Consent Agreement and Order is subject to the approval of the Board. She agrees that, if the Board rejects this Agreement, it will be void, and an administrative complaint may be filed. If this agreement is rejected by the Board it will not constitute a waiver of applicant's right to a hearing on the matters alleged in an administrative complaint and the admissions contained herein will have no effect. Ms. Tamplin agrees that, if the Board rejects this agreement, the Board may decide the matter after a hearing, and its consideration of this agreement

shall not alone be grounds for claiming that the Board is biased against her, that it cannot fairly decide the case, or that it has received ex parte communication.

I, Sarah Tamplin, have read the Consent Agreement and Order, understand it, and agree to be bound by its terms and conditions. I specifically acknowledge that failure to comply with the terms of the Consent Agreement and Order will result in SUSPENSION of my license. The admissions contained herein will be considered proven and the only issue will be failure to follow the terms of the Consent Agreement and Order.
